# **Donation opportunities:**

To secure the future of young lions born in the wild, more protected habitat is needed. Currently, the GWLT is trying to secure a specific area of 3,500 hectares (35 km<sup>2</sup>), which includes the water sources of the entire ecosystem, as a sacred natural site. A lion pride comprises 5-13 animals and needs an area of at least 10 km<sup>2</sup> to exist.
